

The Board of Trustees of Hamilton Township, County of Warren, Ohio, met at a regular session at 6:00 p.m. on February 19, 2025, at Hamilton Township, Warren County, Ohio, with the following Trustees present:

Mr. Cordrey introduced the following resolution and moved its adoption:

RESOLUTION NUMBER 25-0219A**

**A RESOLUTION DESIGNATING FALLER ROAD AS CLYDE BASTON WAY IN
HAMILTON TOWNSHIP FROM THE INTERSECTION OF FALLER ROAD AND
FOSTER-MAINEVILLE ROAD TO THE INTERSECTION OF FALLER ROAD AND
ASCOT ROAD.**

WHEREAS, Mr. Clyde Baston served as a Hamilton Township Trustee for 24 years, volunteered with the Fire and Rescue Department for several years and served the community as a Sheriff's Deputy; and

WHEREAS, Clyde contributed to the Hamilton Township community as founder of Helping Hands of Hamilton Township, as a leader to acquire and establish the first Township park, was a leader in funding for a Senior Citizen building and public library and volunteered as a member of the Miamiville Elementary PTO, among many other forms of civic volunteering; and

WHEREAS, Warren County Engineer Kurt Weber and retired Warren County Engineer Neil Tunison recommend to this Board to honor Clyde Baston ceremoniously designating Faller Road as Clyde Baston Way;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Hamilton Township, Warren County, Ohio to designate Faller Road as Clyde Baston Way in Hamilton Township between Foster-Maineville Road and Ascot Road honoring Clyde's decades of service to Hamilton Township and his 24 years as a Hamilton Township Trustee and direct the Township Public Works Department to erect the signs accordingly.

SECTION 1. This Resolution shall take effect on the earliest date allowed by law.
